CHALLENGE RULES

- ◆ Quilt Expo Challenge open to **ALL** quilt makers.
- ◆ All quilts will be juried; then judged by Nationally Certified Quilt Judges.
- ◆ Quilts must have been made in the last 12 months and must not have been exhibited at any other public quilt show.
- ◆ Each person/group may enter **one** quilt.
- ◆ All persons who stitched on the quilt, including the quilter, must be listed on entry form.
- ◆ All quilts must be made from fabrics and represent the theme of baked items including, but not limited to cookies, pies, breads, and cakes or cupcakes.
- ◆ Quilts may be pieced, appliquéd, mixed or other.
- ◆ All quilts must be quilted through 3 layers by hand or machine or both. Quilts in multiple pieces or in frames are not accepted.
- ◆ Quilts must have a 4" deep rod pocket.
- ◆ Quilts must be 30" wide and 40" in length.
- ◆ Quilts must be clean and in show condition.
- ◆ Quilts must be available from Aug. 18, 2018 - Sept. 30, 2020.
- ◆ Each entry must include **two** 4"x6" high-quality color photos printed on photo paper: one full view of the quilt hanging, showing all quilt edges and one close-up showing quilting/stitching details. Paperclip photos to entry form. Images will not be returned.
- ◆ Each entry requires a separate self-addressed stamped #10 envelope for notification from the jury. Notification letters will be sent July 31.
- ◆ Each entry requires a separate entry form and \$10 entry fee. Make checks payable to **Quilt Expo**. Cash not accepted.
- ◆ Entry form and photos must be postmarked by **June 30, 2018**.
- ◆ Quilts and/or persons who made them may be photographed and/or videotaped for promotional purposes.
- ◆ All decisions by the jury and judges are final. The jury reserves the right to reject any entry.
- ◆ Quilts selected by the jury will be displayed at Quilt Expo September 6-8, 2018 and must be available to travel for display at other quilt shows.
- ◆ Quilts will be returned by September 30, 2020.
